Violent Spring Storm Knocks Over Lots of Trees

What your insurance company pays depends on where the tree lands



The owner of this tree would be eligible to collect \$500 to remove the tree from the property. The policy deductible would also apply.

Sunday March 18th saw a severe line of storms race through central Ohio. We often get calls from people looking for money to clean up trees that are damaged or knocked over ("felled" is the industry term). Anyway, it depends on where your tree lands. The photos at left and right show two situations resulting from the March storms.



This felled tree is resting against the house. The owner of this property will get whatever it takes to remove the tree from the house <u>plus</u> \$500.



One of our agency accounts installed the solar array in the above photo. This array is 4 acres large and provides power to the Centerburg Middle and High Schools. There is also a rooftop unit on the elementary school. With a total of 1.7 megawatts of power, this site is the largest solar installation at any school in the state of Ohio. There will also be a solar lab where the students can learn about alternative sources of energy. According to Michael Hebenthal, superintendent of schools, this installation saves enough on energy costs to put another teacher in the classroom.
