## Fine Arts Insurance Will Be Required

The Andy Warhol painting of Marilyn Monroe titled "Four Marilyns" was recently sold at auction for \$34 million. Paintings of that type require special insurance referred to as Fine Arts coverage. The premium for the Warhol painting would be \$68,000.

Other types of property that we insure on a Fine Arts policy are statues, antiques, porcelains, and tapestries. I once met Dale Chihuly when his work was on display at the Franklin Park Conservatory. He's known worldwide for his colorful glass creations. Over the years' we've written Fine Arts policies for a number of Chihuly pieces.

#### Would You Borrow Someone Else's Rental Car?

I was on a golf trip earlier this year to one of my favorite places on earth—Pinehurst, North Carolina. #### **Power Outages Boost Sales of Whole House Generators**



This system cost about \$7,500 and it takes about \$250/yr in service to keep it in good running order.

The owner of this home in Worthington (see photo) got fed up with losing power. He decided to install a home backup system. Powered by natural gas, this generator comes on automatically in the event of an outage. It ran 3 times in the past year. When the June 29, 2012 storm came through town it ran for nearly a week. Friends and family were invited to come over during that long outage but they declined. People are funny about wanting to be in their own home.

The generator was purchased primarily to cover the circuits that run the sump pump in the finished basement. It runs 90% of the other circuits including the HVAC system, water heater, and refrigerator. The only major circuit not protected is the one for the dryer. Look for the clothesline in his back yard.



Warning Label is Part of Product Liability Insurance

However, all is not lost. Golf has typically been a good game for shorter people. I wonder if JF says "Boy, I wish I could hit a golf ball like Ralph"




Probate Judge gets a Surprise After Minor Traffic Accident

Burnt Wires in AC System Create Puzzling Claim

One of our long-term insured's sent the above photo as part of a damage claim. The photo showed burnt wires inside an air conditioning unit located on the roof of one of his buildings.

To determine if coverage applied, the insurance company hired an outside engineer to write a report. Was there a fire? If yes, then coverage would apply. If not, then coverage would not apply. Even though the report said fire was doubtful, the claim was paid for 50% of replacement cost.

DuPont Weed Killer Damages Ohio Trees

A number of our customers have been affected by this product, including landscapers that applied the chemical. DuPont has established a settlement fund but payment is slow.

Kate's association has been waiting almost a year to receive \$15,000 from DuPont.

# **Major Medical Policy for \$24.63 Per Month**


